5 Review, And Make Recommendations For, Statutes Relating To Firearms And Behavioral Health
6 Issues" is hereby changed by replacing the "State Court Administrator" with a licensed clinical
7 psychologist with over twenty (20) years of experience. The commission is authorized to continue
8 its study and make a report to the General Assembly on or before February 28, 2014, and said
